### Communication of Other Relevant Information

**Madrid, February 28th, 2025**

Following the announcement of "**Other Relevant Information**" (with registration number 32621) published on February 18<sup>th</sup> 2025 regarding the establishment of a temporary share buyback program (the "**Buyback Program**"), the Company reports that, following the latest acquisitions made as of February 27<sup>th</sup> 2025, the purpose of the Buyback Program has been fulfilled and, therefore, it has been completed before the expiration date (set for June 30<sup>th</sup>, 2025).

The maximum number of shares acquisition approved by the Board of Directors for the Buyback Program has been reached, that is, the acquisition of a total of 1,500,000 shares, representing 0.57% of the Company's share capital, for an amount of 18,347,280 euros.

The transactions made on the Buyback Program carried out between February 26<sup>th</sup>, 2025 and February 27<sup>th</sup>, 2025 are reported below, based on the information submitted by BBVA, manager of the Buyback Program.
