OWN SHARES:

On June 30, 2020, the General Shareholders' Meeting authorized the Board of Directors to acquire treasury shares for a maximum period of 5 years. Subsequently, on March 27, 2025, the General Shareholders' Meeting again authorized the Board of Directors to acquire treasury shares for a maximum period of 5 years.

On March 18, 2016, March 29, 2019, March 31, 2022, and March 27, 2025, the General Shareholders' Meeting approved a long-term incentive plan for 2016-2018 ("ILP 2016-2018"), another for the period 2019-2021 ("ILP 2019-2021"), another for the period 2022-2024, and another for the period 2025-2027 ("ILP 2025-2027"), respectively, which included the delivery of shares to Executive Directors, members of the Executive Committee, and management personnel of the Company and its group of companies.

In light of the above and in accordance with the treasury stock policy of the company approved by the Board of Directors on April 18, 2016, the respective share buyback programs were approved by the same on April 18, 2016, April 23, 2019, and April 25, 2022, allowing the purchase of a maximum of 307,643 shares of the company under the first program, a maximum of 405,084 under the second, and a maximum of 679,907 under the third. The buybacks were entrusted to a recognized competent financial intermediary to carry them out on behalf of the company, independently and without its influence.

In execution of the above, the company proceeded to repurchase the maximum allowed under the buyback plan approved on April 18, 2018, leaving a remainder of 96,862 shares after the liquidation of the ILP 2016-2018. Similarly, it proceeded to repurchase the maximum allowed under the buyback plan approved on April 23, 2019, leaving a remainder of 258,579 shares after the liquidation of the ILP 2019-2021, and proceeded to repurchase 465,000 shares under the buyback program approved on April 25, 2022, leaving a remainder of 723,579 shares in treasury stock.

Additionally, the Board of Directors of the Company agreed on February 19, 2024, and February 17, 2025, to carry out a Temporary Share Buyback Program for the year 2024 and for the period 2025-2027, respectively, in accordance with the provisions of Article 5 of Regulation (EU) 596/2014. The aforementioned Temporary Programs have the sole purpose of fulfilling the obligations arising from the Company's flexible remuneration plans for the delivery of shares to employees and executives of Enagás, S.A. and its group companies during the year 2024 and during the period 2025-2027, respectively.

The Company could acquire up to a maximum of 430,000 shares under the Temporary Share Buyback Program for the period 2024, and up to a maximum of 1,500,000 shares under the Temporary Share Buyback Program for the period 2025-2027. The buybacks were entrusted to a recognized competent financial intermediary to carry them out on behalf of the company, independently and without its influence.

In execution of the above, the company proceeded to repurchase a total of 416,522 shares under the Temporary Share Buyback Program for the period 2024, which after the liquidation of the flexible remuneration plan for the year 2024 left a remainder of 142,692 shares in treasury stock. Similarly, the company proceeded to repurchase a total of

1,500,000 shares under the Temporary Share Buyback Program for the period 2025-2027, currently leaving a remainder of 1,433,576 shares in treasury stock after the partial liquidation of the flexible remuneration plan for the year 2025.

The Company currently holds 2,299,847 shares in treasury stock.
